4. Mandatory initial advance payment:

- a) for RF residents and non-residents, who chose Russian rubles to pay for services under the Agreement is fifty-five thousand rubles (RUB 55,000), including VAT (18%) in amount of eight thousand three hundred eighty-nine rubles and eighty-three kopeks (RUB 8,389.83);
- б) for non-RF residents, who chose US dollars to pay for services under the Agreement is one thousand six hundred dollars (USD 1,600), including VAT (18%) in amount of two hundred forty-four dollars and seven cents (USD 244.7);
- в) for non-RF residents, who chose Euros to pay for services under the Agreement is one thousand two hundred fifty euros (EUR 1,250), including VAT (18%) in amount of one hundred ninety euros and sixty-eight eurocents (EUR 190.68);

5. When transferring funds to the account of the .MOSCOW and .MOCKBA Registry-Registrar Agreement, Registrar shall specify in the payment purpose section the top-level domain name .MOSCOW or .MOCKBA, in which the services will be provided. Therefore, the transferred funds may be allocated between the .MOSCOW and .MOCKBA TLDs in proportions specified by Registrar.

When crediting funds to the Registrar's Agreement account, Registry Operator will allocate the transferred funds for the domain name registration services delivery in .MOSCOW TLD and domain name registration services delivery in .MOCKBA TLD in accordance with the information specified by the Registrar in the payment purpose section. If Registrar does not specify the top-level domain name, in which the services will be provided, the transferred funds may be allocated between the .MOSCOW and .MOCKBA TLDs in equal proportions.

* the service may be provided for the period of more than one (1) year, but multiple of one year, provided that the total registration term may not exceed ten (10) years. The service fee in this case is equal to the service fee for one (1) year multiplied by the service delivery period.

** the service includes domain name renewal for one (1) year.

*** start and end dates of the stages of the Special Landrush Period for domain names removed from the list of names unavailable for registration due to name collisions are specified in the document published on the Registry Operator's website at <http://ru.faitid.org/projects/moscow/documents>
